I am seeing it everywhere and while I cannot recommend you use it, due to the lack of FDA approval, I can give you the information so that you can make informed decisions for yourself. Ponazuril is the active metabolite of Toltrazuril, which is FDA approved and available in the US. Starting with the winter edition, I plan to do some medication basics, such as conversions, giving fluids, etc for this year. If there any specific topic you would like me to cover, please let me know.

Dad and I had an amazing and informative trip to the Europa Show in Slovakia in November. I will be sharing all that we saw and learned in our next edition since the winter one is usually lighter on content. # Medication Minute

lizabeth Reichert, PharmD, RPh, MSSW

Brand Name: Tolracol, Zoltrax, Zorabel, Baycox, Cevauril, Chanox Multi

Generic Name: Toltrazuril

Dosage forms: All dosage forms available are compounded and include liquids, pastes, pellets

Uses: Anti-protozoal: Treatment of coccidia

How does it work? Inhibits protozoa enzymes and cell division, damages intracellular structures causing protozoa death

Dosage: 2.5mg/kg one time or 2.5-10mg/kg once daily for 3 days, repeat in 7-10 days if needed

Side Effects: Well tolerated

Storage/Stability: Room Temperature; if treating drinking water, discard after 24 hours as precipitates will form

Slaughter withdrawal time: None established

Notes: NOT approved in the US, prohibited by the FDA for use in food animals; principle metabolite (Ponazuril) persists in the environment and undiluted manure may contaminate groundwater.
